

The projects were recognized last month at the City's 29th annual Community Revitalization Awards, along with additional properties, including: the Clint Hibbard Allstate office on Cottonwood Drive, Greenville Business Center at 888 South Greenville Avenue, Town North Mazda, a church, and eleven residential properties.
