## Richardson Mayor's Summer Internship Program Seeks Business Partners



A worthwhile way to connect businesses with our future workforce, the Richardson Mayor's Summer Internship Program – the result of a partnership created in 2018 between the City of Richardson, Richardson Chamber of Commerce and the Richardson Independent School District (RISD) – provides rising high school seniors with eightweek part-time or full-time paid summer internships.

In its sixth year, the program, which runs June 5 - Aug. 4, immerses current high school juniors who attend Richardson ISD or live in Richardson into the professional

workplace with paid internships at sought-after businesses, nonprofits and government agencies.

In an effort to increase the level of business and community support, **organizations of all sizes are encouraged to sign up by April 13**, to hire or sponsor at least one intern.

Here are a few meaningful ways to get involved:

**Hire one or more interns at your place of work.** Whether you're a Fortune 500 company or a small business, organizations of all types and sizes are encouraged to sign up.

Underwrite one or more interns to work at a nonprofit of your choice. This is a wonderful way to not only teach teens the important role that philanthropy plays in our city but also gives them a birds-eye view of its day-to-day operations.

**Become a program sponsor.** There are many special intern enrichment opportunities to underwrite such as the Workforce Skills and Work-Readiness trainings, Job Fair, Community Service Day, Celebration Luncheon and more.

**Volunteer/share your expertise.** Business professionals are needed to assist on site or virtually with Workforce Skills Trainings. Activities include coaching and critiquing students in professional etiquette and dress, resume development, interview preparation/mock interviews, and business communication.

The program will offer part-time and full-time paid internships in a variety of fields such as technology, manufacturing, communications, professional services, architecture, construction, education, engineering, philanthropy and more. With hours ranging from 12-40 hours per week, interns will earn a minimum of \$12 per hour.

From the art of communications and collaborative work to shadowing executives, planning events and more, interns are introduced to a variety of exciting fields while learning soft skills, technical abilities and lifelong lessons that are best taught on the job. Naturally, the internships serve as an important stepping stone as students prepare for college, trade schools and landing their future dream job.

## **Council Seeks Voters' Approval To Replace Fire-Damaged City Hall**

The Richardson City Council voted Feb. 13 to call a May bond election to raise \$46 million to go toward replacing the Richardson City Hall that was made vacant last August due to fire damage. If approved, no tax rate increase would be associated with the sale of the bonds.

The decision was placed before voters due the unusual situation where repair, renovation and restoration costs would amount to an estimated 70-percent of the cost of a new building. Currently, the cost to repair, restore and complete previously planned renovation of City Hall is estimated at \$60 million. The cost to replace City Hall with a new building is estimated at \$85 million.
