- The hospital is managing the increased number of COVID cases since the re-surge.
- Sales taxes for the city are up year over year for the month of May, but the city is budgeting a drop in the next fiscal year. However, the projected drop is less than other comparable cities in the region and state due to Richardson's B2B diversified business community.
- Large employers are having their employees continue to work remote for the rest of the year, and in some cases well into next year.

- Companies continue to come to Richardson, including Debt-Blu from Addison and Tourit Media from Plano.
- From the chamber's perspective, financially we're managing our resources well and running net income positive so far this year. Debbie Post took over our accounting position. However, three other vacant staff positions are not being filled.

Richardson offers economic relief for Collin County small businesses

The pre-application period is now open for Richardson's new economic assistance program for small businesses in the Collin County portion of Richardson. The City has allocated \$1 million of its Collin County funds from the Coronavirus Aid Relief and Economic Security (CARES) Act to create the program, which will use the same requirements as the program that is eligible to Richardson businesses in Dallas County. Individual businesses with no more than 100 employees and under \$10 million in revenue can receive up to \$50,000 in the form of a forgivable loan.

Businesses can fill out the pre-application online Aug. 1-16; a randomized borrower selection process will take place after the pre-application period closes to identify eligible businesses that will be invited to submit a full loan application. The National Development Council (a third-party administrator) will oversee the screening and selection process. Visit their website>>

Dallas County to offer round 3 of the emergency assistance to businesses

Up to \$50K is available to small businesses in a forgivable loan. Apply Aug. 10-23. Businesses must have lost 25%+ of revenue because of covid-19. <u>Read a PDFabout the program>></u>

Loan deadline approaching for small businesses affected by October tornado

Small businesses affected by the straight-line winds, hail and tornado that hit Dallas County last October have until Aug. 14 to apply for an SBA federal disaster loan for economic injury. Loans of up to \$2 million are available to help meet working capital needs caused by the disaster, regardless of whether the applicant suffered any property damage. Loans may be used to pay fixed debts, payroll, accounts payable and other bills that cannot be paid because of the disaster's impact. <u>more>></u>

Community Impact

More than 2,700 Richardson businesses received potentially forgivable loans through the federal Paycheck Protection Program. The PPP was enacted as part of the federal Coronavirus Aid, Relief and Economic Security Act in April. Most Richardson businesses that got loans received amounts of \$50,000 or less, the data shows. more>>
